#### VILLAGE OF PENDER SALES TAX ISSUE

"Shall the governing body of the incorporated municipality (the Village of Pender) impose a perpetual one and one half percent sales and use tax upon the same transactions within the Village on which the State of Nebraska authorized to Impose a sales tax allocated as follows: one percent (1%) for the purpose of infrastructure replacement and improvement and new infrastructure and one-half (1/2%) for street improvements following the expiration of the current one percent sales tax?"

#### INITIATIVE 427

"Shall Nebraska statutes be amended to provide that the state shall amend its Medicaid state plan to expand eligibility for medical assistance to cover certain adults ages 19 through 64 whose incomes are one hundred thirty-eight percent (138%) of the federal poverty level or below as defined by federal law, and to maximize federal financial participation to fund their care?"
