THURSTON COUNTY BOARD OF SUPERVISORS **PROCEEDINGS**

October 16, 2017

A regular meeting of the Board of Supervisors of Thurston County, Nebraska was held at the regular meeting place of the Board in Thurston County, Nebraska Courthouse in Pender, Nebraska on the 16th day of October, 2017. Present were: Leonard Peters, Georgia Mayberry, James Price Sr., Arnie Harlan, Dan Trimble, Roger Nelson, Mark English. Absent: none. Notice of the meeting was given to all members of the Board of Supervisors and a copy of their acknowledgement of notice and receipt of notice and the agenda is attached hereto. Availability of the agenda was communicated in the advance notice and in the notice to the Board of Supervisors of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. The meeting was called to order by Chairman of the Board Mark English at 9:02 a.m. Chairman English stated that the open meeting laws will be followed during this meeting and are posted on the south wall of the meeting room for anyone that would like to review them. Motion by Nelson, seconded by Trimble to dispense with the oral reading of the minutes, and approve the minutes of the October 2, 2017 meeting as presented. Roll call vote, Aye: Peters, Mayberry, Price, Harlan, Trimble, Nelson, English. Nay: none. Motion carried.

Supervisors Mayberry and Peters informed the board that they had attended the NIRMA workshop, and reported that there was discussion regarding cyber security; laws suits; and managing a meeting. Supervisor Peters reminded the Board of the October 25 luncheon with NIRMA if anyone chooses to attend.

Tom Perez gave his report to the Board on the Emergency Management Department. Tom reported to the Board that he would be attending the drill at the hospital and care center today; last week Tom tested the panic buttons in the offices and all were in working order; tested radios in the villages; classes Tom would like to attend include weather ready nation, debris management, leadership/decision making workshop, homeland security planning; active shooter workshop in Scottsbluff; and he has continued working with different places regarding the standard responses.

Bullet Beaudette gave his report to the Board on the Roads Department. Bullet advised the Board that Cooneys have the work done by the sewer lagoon, should be open this week; they are working on the bridge by Hankins; plugged tube west of Knechts was removed and new tube put in; he received a call last week about a company bringing a crane across the county, and would have to come across H Ave, they crossed an 8 ton bridge with an 80 ton load, they will be checking this bridge closely for any damage; Rail Road wants to close E Ave to work on the crossing, and told the Board that the rail road needs to furnish their own signs to close the roads instead of using county signs; everyone is blading now, mostly dirt roads so that farmers can get into their fields for harvest.

Motion by Trimble, seconded by Harlan to go into closed session to discuss possible litigation. Roll call vote, Aye: Peters, Mayberry, Price, Harlan, Trimble, Nelson, English. Nay: none. Motion carried.

The Board entered into closed session at 9:24 a.m.

Motion by Trimble, seconded by Mayberry to reconvene into opened session. Roll call vote, Aye: Nelson, Trimble, Harlan, Price, Mayberry, Peters, English. Nay: none. Motion carried.

The Board reconvened into open session at 9:29 a.m.

The Board discussed the Ford Explorer from the Emergency Management Department, and if there was another department that might be able to use it. After discussion it was decided that the Sheriff's office is in need of a vehicle, so it will be transferred to that department.

Motion by Peters, seconded by Trimble to approve the contract for signage for the doors at the new jail facility with ASI in the amount of \$3,981.50. Roll call vote, Aye: Nelson, Trimble, Harlan, Price, Mayberry, Peters, English. Nay: none. Motion carried.

The Board discussed with Penny Warren and Franklin Fendrick the request of the Veterans Service Committee to approve her wages to be \$32.14 per hour. After discussion a motion was made by Mayberry, seconded by Trimble, that wages remain at \$28.13 per hour, if Monday of that week is a holiday, time must be made up on the Friday of that week. Roll call vote, Aye: Peters, Mayberry, Price, Harlan, Trimble, Nelson, English. Nay: none. Motion carried.

Budget Authority Tasha Breitbarth spoke to the Board regarding amending the budget for fiscal year 2017/2018. It has been discovered that some revenue that the county received last fiscal year was included in the revenue for this year, but will not be received this budget year. Tasha also told the Board that the budget needed to be amended due to closing and transferring funds from the Jail Sinking Fund, those dollars must be accounted for in expenditures in the budget in order to expend any of the money being transferred, and to allocate for board of prisoner money to be received this year.
